PROFESSIONAL BACKGROUND: Eric van Ginkel is a highly experienced arbitrator and mediator, with full law degrees from both civil (the Netherlands) and common law (United States) countries, as well as a Master's Degree in Dispute Resolution from the Straus Institute for Dispute Resolution at Pepperdine Law School, among the top-rated dispute resolution institutes in the United States.

From his offices in Rotterdam, the Netherlands and Austin, Texas, Eric handles disputes worldwide, involving Business Contracts, Energy (including oil & gas, solar and wind), Intellectual Property, Pharmaceutical/Biotech/Life Sciences, IT, Entertainment and Commercial Real Estate.

ARBITRATION AND ADR EXPERIENCE: Since 2003, Eric has acted as arbitrator in hundreds of arbitrations and mediations. He is an arbitrator and/or mediator for the American Arbitration Association (**AAA** – *Large Complex Cases and Intellectual Property Panels*), the International Institute for Conflict Prevention & Resolution (**CPR** – *the International and Banking, Accounting and Financial Services Panels of Distinguished Neutrals*), the International Chamber of Commerce (**ICC** Netherlands), the International Centre for Dispute Resolution (**ICDR**), the London Court of International Arbitration (**LCIA**), the Vienna International Arbitration Centre (**VIAC**) and the World Intellectual Property Organization (**WIPO**), amongst others. He also serves as mediator on the Panel of the United States District Court for the Central District of California.

Eric is a **Fellow** of the *College of Commercial Arbitrators* (CCA), an international, elite invitation-only fellowship of experienced commercial arbitrators. He also a **Fellow of the** *Chartered Institute of Arbitrators* (*CIArb*), a leading professional organization of alternative dispute resolution practitioners worldwide. It has over 16,000 members located across 149 countries supporting all forms of private dispute resolution worldwide.

Before moving to Texas in December of 2016, Eric resided in California, where for ten years *Los Angeles Magazine* and *Law and Politics Media* honored Eric as one of a small group of "*Super Lawyers*" in Southern California in the "ADR Arbitrator/Mediator" category.

Since 2006 Eric has been a full-time independent arbitrator and mediator. Before then, capping a career of more than 35 years as an international attorney, from 1999 until 2006 Eric was Counsel to Hughes Hubbard & Reed LLP (a prominent international arbitration law firm), in its Los Angeles office, as a member of the Arbitration & Mediation and Intellectual Property Practice Groups.

Eric is a former Assistant Director of the Straus Institute for Dispute Resolution. He is a former member of the Executive Committee and the Board of the California Dispute Resolution Council (CDRC). He is also a former member of the Arbitration and Mediation Committees (Co-Editor of the Mediation Newsletter, 2009-2010), and a past Senior Vice-Chair of the Committee on Intellectual Property and Entertainment Law, of the International Bar Association.

Today, Eric is an Adjunct Professor at the Law School of the University of Texas at Austin, teaching Arbitration Law, Negotiation and ADR Survey (i.e. an overview of Negotiation, Mediation and Arbitration).

Eric is also an Adjunct Professor of Law at the Straus Institute for Dispute Resolution of Pepperdine University School of Law (since 2004), where he has taught courses in ADR Survey, (US Domestic) Arbitration, International Commercial Arbitration, International Business Transactions, International Commercial Dispute Resolution, International Investment Disputes, Introduction to the Legal Process, and the Mediation Clinic (in alphabetical order).

Eric coached teams of Straus Institute students who participated in the First International Commercial Arbitration Moot at American University Washington College of Law in 2012 (on a subject involving international investment arbitration), and the 20th, 21st and 22nd Vis Moot Competitions in Vienna, respectively in 2013, 2014 and 2015 (on subjects involving international commercial arbitration), and has acted as Vis Moot arbitrator in several sessions both in Hong Kong (Vis East) and Vienna, including most recently in 2016 and 2018.

In 2007, 2008 and 2009, Eric van Ginkel taught intensive courses in Advanced Mediation at the Law School of City University of Hong Kong, and in 2010 at the Mediation Centre of the State Islamic University Walisongo in Semarang, Indonesia.

Eric is a frequent speaker and trainer on subjects involving arbitration and mediation.

ADR TRAINING: Eric van Ginkel holds a Master of Laws (LL.M.) degree in International Dispute Resolution (2003) from the Straus Institute for Dispute Resolution at Pepperdine University School of Law. He is also a graduate of the Harvard Law School Negotiation Project. In addition, he has attended numerous conferences, as well as advanced training programs provided by the Straus Institute, the International Chamber of Commerce (including its Master Class in Arbitration), the American Arbitration Association, the International Centre for Dispute Resolution and the U.S. Federal and State court systems.

Eric acted as in-house counsel for almost ten years (involving entertainment, toy manufacture and distribution, as well as a holding company of diversified industries), and in those functions, actively supervised the litigation of numerous court cases in the member countries of the European Union. During those years he was one of the first attorneys promoting mediation as an economical solution for business disputes.

As an attorney with a background in both transactional and litigation law practices, Eric worked on complex international and domestic corporate and business transactions, including joint ventures, bio-technology transactions (including co-development and licensing deals), mergers and acquisitions, commercial real estate developments (including residential, office and shopping center developments), straight and syndicated loans, bank and trust matters, intellectual property related license and distribution agreements, entertainment-related agreements, oil and gas industry arbitrations and employment-related litigation.
